

### Access to Real Time Data

The 2 following examples compares the information accessible to retail investors on the online brokers' website and the consolidated orders book.

#### EXAMPLE 1

- Stock name: SOCIETE GENERALE
- Time & Date of the screenshot: January 13<sup>th</sup> – 13:49:14.915 (CET time)

The consolidated order book view displays the liquidity available on the Home Market but also on the other venues where the stock can be traded.

- On the Bid side:
  - The Home market offers: 10 price levels between 45.250 € and 45.380 € for a cumulative quantity of 7,360 shares.
  - The Best European Bid price is available on the Home Market at that exact moment.
- On the Offer side:
  - The Home Market offers: 10 price levels between 45.445€ and 45.400€ for a cumulative quantity of 9,001 shares.
  - The Best European Offer price is available on BATS: 45.390€.

- Time & Date of the screenshot: January 13<sup>th</sup> – 14:24:07.954 (CET time)

- On the Bid side:
  - The Home market offers: 10 price levels between 1.927 € and 1.944 € for a cumulative quantity of 73,242 shares.
  - The Best European Bid price is available on Chi-X at that exact moment.
- On the Offer side:
  - The Home Market offers: 10 price levels between 1.958€ and 1.948€ for a cumulative quantity of 727,753 shares.
  - The Best European Offer price is available on Equiduct: 1.947€.
